Langley is in desperate need of before and after school care and I believe with proper planning every new school could have childcare included. It is such a struggle for families to access this care and the perfect setting is where your child is already spending their day so that parents have a single drop off and pick up point. I also feel that many of the existing schools have empty classrooms after school hours so investments can be made into those spaces to make them easily converted into before and after school childcare.

How will you advocate for increased public funding? (open comment response)

Megan Dykeman	As a trustee I have worked tirelessly to advocate for increased funding, with the board and in my capacity as our school district provincial council representative. I would continue to advocate as a I have, as well as look at ways to increase communication with the Minister of Education in order to build our relationship further. I would also like to work with our partner groups to examine ways to enhance advocacy in a coordinated way. As a BCSTA provincial council representative I have had the opportunity to advocate for changes in how the funding is generated, to move away from grant funding and advocate for increased block funding for our students. One time grant funding creates uncertainty and inequity in the system. If re-elected I will continue my advocacy for these changes.

How will you advocate for increased public funding? (open comment response)

Rod Ross	I believe we need to create our own wealth. We generated \$14M last year from International students tuition. Langley must take care of itself. I support asking for increased funding but would not hold my breath. If you look at all the \$ created via ISP revenue in BC the government has a long way to even meet current needs.
Cheryl Snowdon-Eddy	Working with my fellow trustees, I would approach the Ministry of Education to release funding that is at lease adequate to meet our needs. This has not been done efficiently and I would like to learn how to make this happen.
David Tod	As a Board, we have written letters to the Ministry for capital funding. We also use the BCSTA to advocate for better funding of your public schools. I have presented to the select standing committee on Finances for increased funding for our schools.
Marnie Wilson	School Boards need to work more closely with all levels of government to highlight the need for more funding. The student funding formulas are grossly inadequate and the budgets for capital funding for new schools are sparse. I believe if all boards turned their voices to this and made it their number one priority they could make change.

Marnie Wilson	Staff, Schools and Programs. Over a month into the new school year and there are classrooms that are still without a teacher. The shortage of teachers and support staff must be addressed immediately. We need to work with the township to plan schools where we know development is happening. It is to late if we wait until those developments are built and families have moved in before we begin to plan for a new school. We need programs to support special needs students who often need more intense programing and programs to address mental health issues that are becoming so prevalent in society today.		

#10 What is your plan to consult with stakeholders in your decision making process as a Trustee? (open comment response)

Megan Dykeman	My three core values as a trustee are accountability, communication and respect. From the time I was first elected until now I have worked to increase the communication and consultation with our partners and stakeholders and ensure that we are accountable and respectful as a board. Just this past year I moved the following motions, to enhance communication, which were supported by the Board: The first was to strike a communication committee. Although I believe that overall the board has worked hard to ensure that true consultation has taken place over this term, improvement is always possible and I am looking forward to hearing from our partner groups how this can be improved. The second was a motion which I have moved continuously since being elected. Implementing web streaming of School Board meetings. This was important to me for two reasons, the first being that many parents in the district cannot make the times when our meeting are held. The second being that governing in an open and transparent way is so important. Finally after 7 years, the Board supported this motion, and the regular meeting are now web streamed.

Candy Ashdown	I served for eight years on the PAC Executive at both of my children's schools (Langley Public schools). Six of those years, I held the position of either PAC President or Vice-President. It was an honour to represent the parents at our school and I have such wonderful memories of all of the great work we did together. I also served on the DPAC Executive for two years. In 2011, I made the decision to step back from my position on the DPAC Executive and I put my name forward for a Langley City seat on the Board of Education. In 2011, I was honoured to be elected by Langley City residents to the Board of Education. I served until December 2014. I am very proud of what our Board accomplished in those three years. We paid off a \$13 million-dollar deficit (from a previous Board's term) a year early, hired a new District Leadership team, developed a much-needed Long-Term Facilities Plan, developed a Communications Plan, as well as a new Mission, Vision and Values Statement and also formed Liaison Committees with both the Township and City. Our Board made it a priority to repair broken relationships with partner groups and regain the trust the district had lost in the community. Transparency and true public consultation were always at the forefront of our work.

Marshall Austin	I am proud to have served as the Director for Community Outreach with the Aldergrove Business Association. The focus was on engaging at risk youth in the Aldergrove region to support them to be successful in school and then ultimately in the community. The goal was to create support mechanisms and safe opportunities for the kids to make education a priority when facing other life challenges. Additionally I fully support intern programs through my work and partner with several organizations to allow students preparing to enter the workforce to have mentoring and hands on experiences to supplement their formal educations.

Another contribution that I am proud of has been my work on the Policy Committee. Soon a recommendation will be coming forward to the Board on how, as a district, we respond to substance use. Substance use is a real problem in our district, and early intervention, in the right way, with the appropriate actions, is crucial. This has not been an easy policy to develop and I appreciate the very hard work of the District staff and my fellow trustees for their support on this very important initiative. And finally, although I am super proud of my public stance on SOGI123 and recognize it at as very important contribution, I believe my greatest contribution that I have made to date is the graduation address I delivered to the graduates at Vanguard Secondary last June. I believe that through sharing my story and encouraging them to be proud of theirs and never being ashamed of who they are and where they have come from, that I made a meaningful difference in their lives that night. Even greater than this, I believe that each one of these graduates will in turn go out, share their stories, and make a difference in the world around them.

However, our City and Township are both growing quickly and extra space in our schools is becoming limited or non-existent. I 100% support child care on school sites, if there is room. However, if there's not room I believe we need to work with our Township and City to look at options in municipal facilities of close proximity to the school. This is one of the many reasons that it is so important to have a very good working relationship and communication with both the City and Township.						
Marshall Austin	Yes, I see a need for childcare on school sites. We have an obligation to provide resources and tools as well as a safe environment to our students not just during school hours. Students need to know that there well being is top of our minds when not in the immediate care of their parents.

Shelley Coburn	Yes I do see a need for childcare on schools site and in the past, as a district, we had more space and were able to have onsite childcare. Unfortunately, with the restoration of the language by the Supreme Court back to 2002 levels, and the extremely rapid growth in parts of our district, we no longer have the space we once had. I am very much willing to pursue this with any level of government who is willing to work with us. I think that we need to look past the Province as the only government that we need to advocate. We need to get innovative and we need to expect more form our local governments and developers. Schools are an important and necessary part of our communities and development impacts us substantially. We are expected to accommodate the growth yet have little influence over how this growth happens. We need growth that we can sustain, and collaboration with local government is how we may best address this situation. If we no longer have space in our buildings for childcare because of growth, then it is time that we advocate for childcare centres in our new developments. We have mixed use residential with retail so why then can we not have mixed use residential and community amenities? Our capacity problem is complex, and we will need to be innovate if we want to meet the needs of our families and our communities.

Candy Ashdown	Through the Board, I would encourage ongoing good communication and also support building a strong relationship between the Board of Education and the Ministry of Education. I would advocate for an increase to funding of public education, including funding for new schools. The Province needs to work on the funding formula. They also need to change the process in which funding for new schools is approved. A new school takes over two years to build. It's not at all appropriate that funding a new school is not even looked at until the students are already there in an overcrowded school. Much work and advocacy still needs to be done.						
Marshall Austin	We need to have a strong voice and be heard with all vested partners in particular the ministry. This will include collaboration and attending key meetings with key stakeholders ensuring that Langley's specific needs are met, that our unique demographics are supported and that the current formula for funding is challenged based on our districts particular needs as well as contractual commitments. We must build strong business cases to advocate and be heard.						

How will you advocate for increased public funding? (open comment response)

Shelley Coburn	As a Board we are always advocating for increased funding. This term may require us to get somewhat more vocal and communicate more to the public exactly how pressing our capacity issue is becoming. As a Board we must be very honest about our situation, not just to the Province, but to the local community. The growth in Langley is rapid and our infrastructure cannot keep up. We need to forge very strong relationships with our local governments and we need to advocate to the Provincial government together. We need the support of our local governments when we go to the Province. Strengthening this relationship is something I have every intention of doing.						
Sindy Jeffrey	As a district we will have to push for more Provincial funding. We would show the needs we are lacking and make our proposals.

Candy Ashdown	Many parents in the Langley School District are concerned about overcrowding and space for their children in their neighbourhood schools and rightfully so. With underfunding of education, I also feel that there is an increased pressure on parents to fundraise, mostly through their school PAC. Most Parents are already stretched so thin financially and living paycheque to paycheque due to the cost of living. They can't afford to pay for playgrounds, computers, books, etc. and should not be expected to. Another priority which I feel many parents in the District struggle with is support for students with mental health challenges. I believe our District can do a much better job of supporting these students, including an increase in Counsellors and support for Teachers in the classroom. Mental health supports play a critical role in student success and their well-being.					
Marshall Austin	In researching this topic and in consultation with many parents I heard that some of the top priorities are: Safe and inclusive environments for all students success is important. That the explosion of growth in our region will continue and we must look towards the future. investments and commitments must be made now to ensure we can succeed in the future. Students want even more opportunities then current in regards to technology, it is essential that technology is embraced and we allow our students to have opportunities to use and learn all types of technology so they can be successful in life after school.

Shelley Coburn	Wow this is a tough question because every family is unique. For the most part I think better communication is something that I hear often from parents, and really it is not just parents that I am hearing this from. Admittedly, as a parent I can say that there have been times I find myself frustrated with how the information is flowing. I have two sons at two different schools and I admit sometimes this can be overwhelming as every school is communicating differently. This may be necessary for somethings, however, there are many things that I would appreciate uniformity in how it is reported, and I know I am not alone. We need to make sure our communication is relevant, consistent, transparent, and timely. Another concern I hear often is around safety and mental health. I am hearing more and more from parents that this is a real issue in their families and they do not know how to support and advocate for their child, they just do not know where to start. They are unsure how to access resources, or where to even begin looking for the resources available to them within the district and throughout the community. This is something that as a district we can support our families in. Making this information easily accessible to our parent community is a top priority in my next term. Finally, I have been hearing more and more about development and how this impacts our existing issues around capacity.
